## 2. Problem:

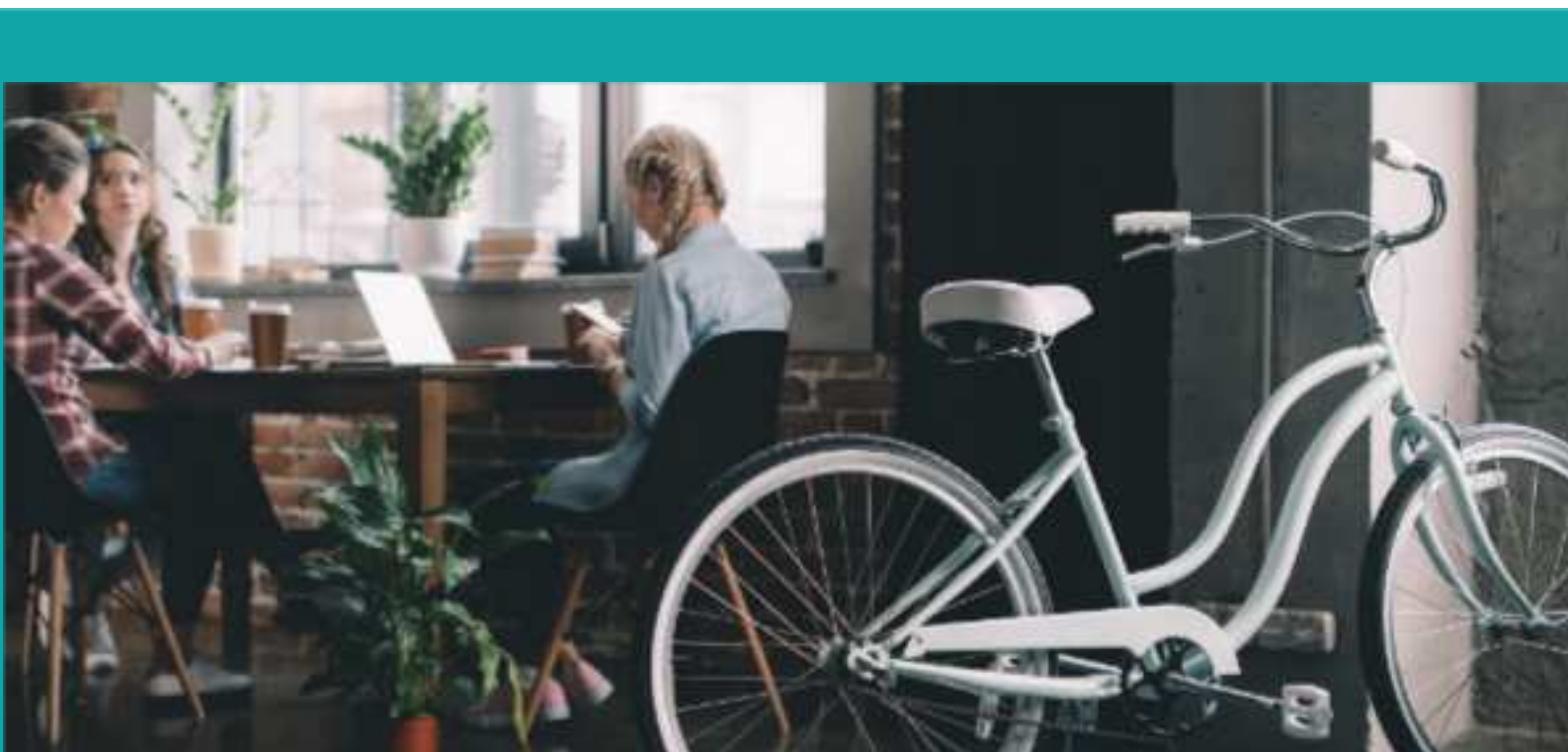

However, when training is done virtually it becomes increasingly difficult for agencies to monitor each caregiver and their time spent training, as every individual completes it on their own time.

## 1. Solution

### **3. Problem**
